1. The Employee's Supervisor must initial this form where indicated.
2. This accounts authorization form is valid only if signed by Ed Nolter, Jeff Brown, Aaron Yoder, Josh Lister, J.R. Murry or Jennifer Long.
3. The authorization form will only be valid for a period of 60 days from the date it was signed.
4. Twelve specific wrap frames with integral side shields have been selected for this account. Please ensure you are using a style listed on the prior page.
5. Metal frames are NOT allowed.
6. This account requires the use of polycarbonate lenses. Plastic and glass lenses are NOT allowed.
7. Tinted, Polarized and Transitions are NOT allowed.
Exception: Executive and Maintenance employees may have transitions but it is their responsibility to pay for the full upgrade.
8. Function of Beauty will pay up to \$160.00 towards SV and FT28 base packages. Any hard coats, anti-glare and progressive upgrades are allowed but are collected in full from the employee.
9. Any employee balances get collected in the office and must be paid in full at the time the order is placed.
